### 1.0 OBJECTIVES

To establish a process for Aboriginal Voluntary Self-Identification of First Nations, Métis and Inuit students.

## 2.0 DEFINITIONS

In this policy,

- 2.1 Aboriginal peoples: First Nations, Métis and Inuit.
- 2.2 **Self-Identification** refers to the voluntary, confidential, self-described declaration of Aboriginal identity;
- 2.3 **District** means the Ottawa-Carleton District School Board;
- 2.4 **Voluntary** refers to Aboriginal student choice (parent/guardian if under 18 years of age) with regard to disclosure of Aboriginal identity.

### 3.0 POLICY

- 3.1 All parents and/or guardians of Aboriginal students, and students who are 18 years or older, have the right to voluntarily self-identify. The District shall provide a mechanism in order to support the self-identification process for Aboriginal students.
- 3.2 The District, in partnership with Aboriginal parents/guardians and the Aboriginal community, aims to realize the learning aspirations and potential of First Nation, Métis, and Inuit students by focusing on quality programs and services.
- 3.3 The identification, collection and aggregation of student achievement data for Aboriginal students assists in determining the success of programs currently delivered, and provide information for future decision-making surrounding program supports and services required to ensure the success of Aboriginal students.

## 4.0 SPECIFIC DIRECTIVES

#### Collection

4.1 The District shall collect the self-identification data through the student registration process for new students and through a voluntary self-identification form for students already enrolled.

#### Storage

4.2 All self-identification data shall be securely stored, in the same manner as Ontario Student Records, and is protected and governed by the *Municipal Freedom of Information and Protection of Privacy Act*.

# <u>Use</u>

4.3 Self-identification data shall only be used as provided for by the Education Act and as a means to enhance Aboriginal education programs within the Board. Information gathered shall be used in the aggregate only, and only for the purpose of developing and implementing supportive programs.

# **Data Sharing**

4.4 Individual student data shall not be shared or communicated unless specifically provided for in legislation and/or requested by the parent/guardian of the child.
