Cultural and Religious/Creed-Based Days of Significance

In April, the Student Senate discussed the OCDSB's recognition of different cultural days of significance. The OCDSB recognizes various <u>days and months of significance</u> throughout the year. Many <u>religious/creed-based days of observance</u> are observed by students across the District. On <u>Starred Dates</u>, no events or evaluations should be held unless there are significant extenuating circumstances. The Senate recognizes that not all students are aware of this policy and what options are available to them. If by chance there is an evaluation on a Starred Date, students can make accommodations with their teacher and principal to take it on another day. The <u>procedure</u> states that no district-wide examinations will be scheduled on any of these days. To avoid too many scheduling conflicts, each faith group was restricted to a maximum of three instructional days, however, students are allowed to be absent from school to observe holy days, including those not designated as Starred Dates.

Sub-Committee updates:

Policy:

The policy sub-committee is currently organizing a district-wide survey collecting student experiences related to the Student Senate's past, current, and future initiatives.

Equity Diversity and Inclusion (EDI):

The EDI sub-committee has created April's edition of the EDI spotlight, a form to celebrate a student in your school community who promotes and upholds the values of equity, diversity, and inclusion. Nominate someone using the <u>Nomination form</u>

Revised Elementary Program Review

The OCDSB has updated its plan for the elementary program review after getting feedback from over 10,000 parents, caregivers, students, staff and community members Key changes include:

- School Boundaries & Grade Configurations
 - The new plan makes adjustments to the proposed school boundaries and reduces the number of schools with split grades like K-3 and 4-8 schools. This change will result in some Enhanced English and French Immersion-only schools.

• Student Movement

The number of additional students needing to switch schools is reduced by half compared to the initial proposal.

- *Process to Consider Exemptions* A new process will be put in place for parents to submit requests for exemptions based on specific cases.
- Support for Students The number of phased-out Specialized Program Classes will be reduced from 39 to 26.
